#### 1. WELCOME & OPENING REMARKS

Wilf Zerbe, Campus Executive, welcomed the Council to the FDU-Vancouver Campus. The Co-Chairs opened the meeting.

#### 4. COUNCIL BUSINESS

#### 4.1.Council Membership

Rob Fleming introduced Laureen Styles, newly appointed member, to the Council. Laureen holds the role of Vice-President Academic and Provost at Capilano University.

# 4.2.BC Transfer System: Interest from Saskatchewan PSIs

Saskatchewan post-secondary representatives (from Saskatchewan Polytechnic and University of Regina) have recently expressed an interest in leveraging BC's Transfer Credit System (TCS) technology to support inter- and intra- student mobility in their own province. (Mike referred members to statistics regarding movement of Saskatchewan learners to BC post-secondary institutions.) BCCAT's policy 3B: Listing of Transfer Agreements with Non-Member Institutions in the BC Transfer Guide (www.bccat.ca/system/membership) would allow for this kind of initiative.

Meanwhile, they are also looking at Alberta's technologies as that is a similar platform. Discussions will continue at the next Learner Pathways meeting on December 17. Updates will be provided at future Council meetings as discussions continue to unfold.

# 4.3. Provincial Issues and Developments

#### 4.3.1. Ministry Update

Jamie Edwardson provided a brief overview of recent issues and developments at the Ministry, touching on the following:

#### 4.3.2. Ontario Supports Innovative College Partnerships

Rob Fleming referred members to this news article; Ontario is introducing a new policy to support public college-private partnerships. Initially, this mainly involves six colleges, and the focus is mainly on international students.

These developments raise questions regarding partnerships with participating private colleges in BC, including for quality assurance, transparency, and transferability. Jamie Edwardson confirmed that an Ontario policy framework is in development, but not yet finalized, and the BC ministry is actively seeking clarification and consultation with their Ontario counterparts.

#### 4.3.3. Proposed Process for Funding Conference Presentations

Robert Adamoski raised this issue which was discussed initially at the October 2019 meeting. Following those discussions, BCCAT staff drafted a proposed process for funding conference presentations by those involved with BCCAT projects, including both contractors and standing committee members.

Members raised the following points as feedback:

- The importance of considering environmental impact of travel.
- Flexible timing/scheduling of presentations as appropriate (i.e. could be at an interim stage of a project).
- Committee to deal with specific requests and reports; this should be included in the text of the process.
- This funding would be helpful particularly for those from smaller institutions and tighter budget constraints.
- There should perhaps be a back-up individual to consider funding requests, where it may pose a conflict of interest for the TAC Chair.
- How do we decide how many people should be involved with any given presentation?
   Should there be a single designate?

The proposed process was approved in principle, but members requested that staff work out further detail based on today's feedback.

#### 4.3.4. Education Planner BC Update

Karen McCredie gave a brief update on recent developments regarding EducationPlannerBC. They are continuing to work with public post-secondary institutions to onboard. To date, 21 out of 25 are on the platform, and it is expected that all will be onboard by summer 2020.

EPBC's Engagement Team have been holding information workshops for parents over the last few months. BCCAT and EPBC staff also presented together at recent Education & Career Fairs (ECF) through November and December 2019. EPBC have also been going to secondary schools, presenting for Grade 10 Career Life Education classes.

EPBC is participating in the national digital data exchange network project being led by ARUCC, and is also in the process of becoming a signatory for the Groningen Declaration.

A proposed budget for 2020/21 identifying new work plan projects will be presented to Council at the March 2020 meeting.

Mike Winsemann referred members to a summary regarding the 2019 JAM event, noting that it had been well-attended, and CATCAN participants had also participated. # 5.4. Transfer Innovation (TI) Projects

# 5.4.1. TI Program Review

The subcommittee overseeing the TI Program Review is working on a proposed outline for restructuring the TI program, which will be discussed at the next TAC meeting. It is expected to be finalized by April 2020, with a view to re-launching the program this year.

# 5.5. Transfer Agreement Maintenance

Transfer agreements on the TCS require improved attention to maintenance going forward. Mike was able to gather feedback at the 2019 JAM event, and a TCS data audit resulted in approximately 30% changes to course listings in the BC Transfer Guide. In 2020, transfer reports will go out to post-secondary institutions highlighting agreements that have not been reviewed for 10+ years to encourage regular updates.

#### 6. ADMISSIONS

#### 6.1. Admissions Committee (Last Meeting: October 11, 2019)

The last meeting of the Admissions Committee focused on key projects (block transfer and degree partnership pathways, and for competency-based admissions processes and assessment), and proposed projects for next year.

# 6.2.Block Transfer Agreements: Implementing and Communicating BTAs in the BC Transfer System

This project looked at the issue of how to ensure block transfer listings are kept up-to-date, and that this information is readily accessible to students. # 8.1.BCCAT.ca Redesign Project

The redesign of the BCCAT.ca is going well as content is being updated and revised according to the new web structure. The refreshed site is expected to be ready to launch in January-February 2020.

#### 8.2.BCTransferGuide.ca Enhancements

The BC Transfer Guide website is undergoing minor changes this year, based on the findings of the external review. Plans are to carry out more substantive changes next year. A key priority will be to use nomenclature and navigation that is more accessible to "non-expert" users.

# 8.3. Transfer Credit System (TCS) Update

Mike updated on the new, "atomic" data model for the TCS at the 2019 JAM. Changes to the TCS will include an improved evaluation interface, additional automation and new features requested by users to allow them to better manage their articulation activities. Changes to the system will go live in by March, 2020.

By signing on to the declaration for the Executive Director to become a signatory, BCCAT would be reinforcing clear support for these principles and goals. A number of provinces, and individual institutions and organizations have already signed on to date.
