3. Z-Cred

Information presented by Mary. “Zero cost credentials” means zero tuition and zero textbook cost. BC gov’t very much behind open textbooks and courses to lower cost of education. Open textbooks have many advantages, especially that they are adaptable.

BC Campus got approx. \$500,000 for z-cred, especially for ABE and the Adult Graduation Diploma. Six-member steering committee tried to determine areas of most need.

Student Success was approved for one of the electives. BC Campus researched what is already available, and there were six related open source materials. Mary put in a proposal for student success, will go through the open sources, collate materials into a new textbook, and create needed chapters to meet articulated learning outcomes. EDCP online course marking guide is one of Mary’s goals and was supported by the committee.

Funding available for more courses. Projects are listed on the BC Campus site. Proposal deadline March 18th, 2019. If someone is working on WE, PF, social studies, and other available courses, consider putting in a proposal. Up to \$10,000 per textbook.

Transfer Guide is slowly accumulating institution’s transfer agreements with institutions outside of BC.
